

Option 1

Strengthen provision at Aotea College, by changing some or all of the northern area primary schools to Year 1-6 and creating Year 7-13 provision at Aotea College

Strengths of the option	Would make the Year 5/6 team stronger and get more experience as leaders There would be more space to play in with less students.
Weaknesses of the option	What would happen to the year 7/8 teachers? Would they lose their jobs? The year 6s aren't ready to be leaders - it would put pressure on them. We would lose the year 7/8 senior council (who organise fundraisers and support whole school events) Less school donations might mean less activities Families would have to pay more for transport to get to the new school Younger students wouldn't be able to walk home with older siblings so wouldn't be 100% safe Senior children hold the school together No-one wants to go to a junior college - we would prefer to stay at Paremata. Aotea would have to build more classrooms. Peer mediators are Year 7/8 and they help to keep people safe in our playground Older buddy classes help the younger students to learn, finish work, and read with them. Year 5/6 would have to change to be for Year 6 children The younger kids wouldn't have the Year 7/8 students to look up to. What would we use the empty classes for? Will we have to get lots of younger children? Year 7&8 should stay because they are very lovely. Could other kids from the area go to other school? Aotea College will get too crowded with year 7/8's going there. We would lose teachers with skills and talents we need . We aren't crowded and we can make our school a bit bigger. It might cost a lot of money.


Option 2

- On a new site in the south of the Aotea Development, or
- At or near Aotea College

Strengths of the option	We would prefer a new school to be built so we don't have to change as we aren't overcrowded.
